

BANDERA SUMMER TENNIS PROGRAM

*Attached is a calendar of events.

*Tennis courts will be open to the public for practice on a first come, first serve basis except when scheduled events are going on.

***Open matches** will be scheduled by Coach Postert but run by the participants. Players will play 8-game pro-sets with a one-hour limit to keep matches moving, with a 5-minute warm up time to start. You must provide your own racquet and balls. The following are dates for matches and registration deadlines (entries are limited so don't wait), you'll need to e-mail Coach Postert to sign up and then match times will be e-mailed to you:

***MiniCamps** will be scheduled and run by Coach Postert. Players must provide their own racquets but balls will be provided. The cost of the MiniCamp will be \$20 per person per camp. Costs will include two 3-hour practice sessions, tournament, and a T-shirt. The following are dates for the camps and registration deadlines, you'll need to e-mail Coach Postert to sign up. The first two days will be practice sessions from 9-12 and the third day the tournament will be held beginning at 9 am. Entry spaces are limited and entry fees are due within two days of when you sign up.
