

Bandera High School Bulldog Basketball Club Charter

The members of the Bandera HS Bulldog Basketball Club submit for public record the following Charter for Bandera High School.

I. PURPOSE:

A. To promote and stimulate growth, support and participation in Bandera High School/UIIL competition Basketball.

B. The Club will meet and hold fundraisers and accept donations to help offset the rising cost of supporting the sport of Basketball and will plan community projects for the off-season.

II. MEMBERSHIP REQUIREMENTS:

A. Membership will be limited to Bandera High School male & female athletes, grades 9-12, currently participating and training in an approved BHS athletic period and after school for BHS Basketball.

B. All members must meet BHS School, athletic and UIL guidelines for participation for the current school year in High School athletics. This includes but is NOT limited to, being academically eligible. Any Athlete/Basketball player NOT in good standings academically and athletically, will lose membership in the BHS Bulldog Basketball Club.

C. Membership end when a member fails to train and participate fully as required by his Coaches /sport guidelines, is dismissed from the BHS Basketball Program, and/or when the said member is no longer enrolled as a full time student of Bandera High School (this includes but is NOT limited to graduating Seniors)

III. MEETINGS:

A. All meetings will be held at Bandera High School unless special circumstances force a need to relocate to another location.

B. Meetings may be of two types:

1. EXECUTIVE MEETINGS: Bandera HS Basketball Staff (Coaches) and at least ONE officially elected student-athlete officer of the Bandera H S Bulldog Basketball Club

2. GENERAL MEETINGS: Bandera Head Basketball Coach or his appointed representative (Assistant Coach), a quorum of Student-elected officers, and any and all members of the aforementioned Club.

C. Meetings will be convened at least once per month and will be announced in advance during Bandera HS athletic periods and over the school public address system.

IV. OFFICER SELECTION:

A. Officer election will be selected the 1st Semester of each new school year through nomination and secret ballot elections.

1. Election of any given office will be on the basis of a simple majority vote and will take place the 1st "Club" meeting of the year.

B. Bandera HS Bulldog Basketball Club Officers and responsibilities will be as follows:

1. President: direct meetings in accordance to agenda(s) and Club Charter

2. Vice President: assist the President and Secretary/Treasurer as needed and directed by those two offices and the BHS Baseball Coaching staff. The VP will serve as acting President when the officer is NOT present.

3. Secretary/Treasurer: records minutes of every meeting and keeps all other officers informed on the fiscal status of the Club.

V. DISTRIBUTION OF FUNDS:

A. Will be made to assist the BHS Basketball program in accordance with BISD administrative guidelines.

B. Distribution of Bandera HS Bulldog Basketball Club funds, as raised by the Club, will be based on simple majority vote of all members present at a meeting designated for that purpose... if a quorum is NOT present at the proposed meeting, then the Coaching staff and officers will make the decision to distribute funds based on a simple majority vote and in accordance with BISD administrative procedures.

C. Funds are the sole discretion of the Bandera HS Bulldog Basketball Club (having raised them) and are NOT subject to any other entity without the Club's written permission.
